E-MAIL ASSISTANCE SCAM

The following E-Mail is an example of an E-mail Assistance Scam.

Dear Beloved,

Please, I have a problem which I'm seriously searching for someone who will help me out. I am a widow and a devoted Christian, my name is Mrs. REYNA BAROS from Australia married to thai for 30years

Since my husband died, I have been suffering from arthritics, and lately doctors have diagnosed me with terminal cancer that left me with approximately one month and some weeks to live.

I am not afraid of death no more because my bible tells me that all soul shall die and come to the creator. It is my turn now and one day, it shall be your turn, Please, if you are sure of your heart, and you are sure that you will do what I asked you to do, kindly write me,

I am currently on wheelchair and being looked after by two nurses I paid every day.
